## LICENSURE REQUIREMENTS BASED ON JURISDICTION IN THE DMV AREA

The following document provides information about obtaining a license in the Washington DC area (Maryland, Virginia, and Washington DC). The information has been reviewed by members of the Social Work Licensing Boards in those jurisdictions. HOWEVER, this information is NOT meant to replace the information that is provided by each respective Boards' websites, as information can change regularly. In addition, this document is not an exhaustive explanation of each jurisdictions' requirements. Consumers of this document are strongly encouraged to review the posted information provided by the respective Licensing Boards. This document is meant to be a useful guide to be used in navigating issues regarding licensing.

on the required forms "not less than 2 vears (104 weeks) and not more than 6 vears. The documentation must reflect that the applicant has met the requirements within a 6 years window of time. In other words, an applicant who receives the LMSW in May 2012 is not eligible to apply for advanced licensure prior to May 2014 at the earliest. In order to use the beginning time of experience in 2012, the individual must meet the requirements by May 2018. If not, then earliest time "drops off" and the "clock" begins at 2013 and runs until 2019.

With respect to registration of supervision, there is no limit as to when supervision must begin after graduation. However, once the applicant has registered their supervision and the Board has approved the supervision then the applicant has 2 to 4 years to complete supervision.

## RELATIONSHIP BETWEEN JURISDICTIONS

## Reciprocity with other jurisdictions/states

To apply for a DC license "by endorsement" means that you currently hold a license in another jurisdiction and are applying for that same level of licensure in another. For example, if I hold an LCSW-C in VA and want to get an LICSW in DC (that is the equivalent clinical license), then I fill out the same "new license" application, but check off the box that says "endorsement" instead of exam. This means that the applicant is using their status of having previously passed the ASWB exam, and currently holding a license "in good standing" elsewhere.

The advanced level has 2 paths of endorsement - one for those who have held the equivalent licensure < 5 years (application must document the meeting of the current MD requirements) and one for those who have held equivalent licensure for > 5 years (passed a licensing exam, worked at the advanced level for at least 5 out of the last 10 years).

(Last piece on practice allowed for maximum of 6 months with an out-of-state license stays the same. However that is only with an application pending.)

Virginia does not offer reciprocity with any other jurisdiction, but it does offer "License by endorsement". Endorsement allows an applicant with a comparable license in good standing in another state to use that license to obtain licensure in Virginia.

What is the process for "Endorsement" between jurisdictions at the LG level?	The applicant needs to pay the \$230 fee for the application and license, as well as the \$50 fee for criminal background check, 3 letters of reference, etc., plus have the state in which they currently hold their license send verification to DC, and have ASWB transfer their exam score to DC.  Submit a complete signed application to the DC Board for the LGSW by endorsement, 2 recent passport photos, Transcript for MSW, 3 character Reference forms, Criminal Background Check, request for Score transfer from ASWB to DC and also Request for License verifications to be sent to DC from all State of licensure, copy of current license.	Endorsement available at all licensure levels. The LMSW requires holding the equivalent licensure in another jurisdiction, the passing of the national exam, & official transcript. There are 2 "paths" of application for licensure by endorsement at the advanced level: one for those who have held the advanced license for 5 or more years and who have been practicing at that level for at least 5 out of the last 10 years and the other for those who have held the advanced license for less than 5 years. For the less than 5 years applicants, the application requires the documentation of experience and supervision that demonstrates meeting the current MD requirements for the advanced licensure. The test does not need to be re-taken but an Official Score Report	To obtain an LCSW in Virginia by endorsement the applicant must submit (1) a complete application and fee; (2) documentation of social work licensure in good standing obtained by standards required for licensure in another jurisdiction as verified by the out-of-state licensing agency. Licensure in the other jurisdiction must be of comparable type as the licensure that the applicant is seeing in Virginia; (3) Verification of passing score on the ASWB exam at the level for which the applicant is seeking licensure in VA is required. (4) current National Practitioner's Data Bank report; and (5) certification that they are not a respondent in any pending or unresolved board action in another jurisdiction or in a malpractice claim.
